It includes the most recently available information from regional, national and some European and worldwide statistics on the number of asylum seekers and their circumstances. Please note that not all the information relates to the same period largely due to the different publication dates of some source material.

There may be some variation in totals for the same period in different tables; this is because some figures some figures come form different sources and others may have been amended at a later date.



Summary

- 1. As at June 2004 there were 4636 asylum seekers in the North East, a decrease of (6.19%) from March 2004. The majority, 1586 (34.2%), are living in Newcastle upon Tyne [Page 4 and 5]
- 2. The main nationalities of asylum seekers in the North East are Iranian (11.3%), Iraqi (9.4%) and Afghan (6.1%). [Page 6]
- 3. The total number of asylum seekers in the UK who are supported by NASS (The National Asylum Support Service) is 70,600, a decrease of 7% from the previous quarter. Greater London has the largest number with 20,330 followed by Yorkshire and the Humber with 10,315. [Page 7]
- 4. Asylum applications in the quarter nationally have reached 7,920, a decrease of 11% from the previous quarter. The main countries of origin were Iran (8.6%), the People's Republic of China (7.5%) and Somalia (6.8%). [Page 8]
- 5. The number applying for NASS support nationally was 7,695, an increase of 4% from the previous quarter. The main countries of origins were Iran (10.7%), Iraq (8.5%) and Somalia (7.3%). [Page 9]
- 6. A Total of 11,720 asylum applications received initial decisions, 2% lower than the previous quarter. Hence the number awaiting a decision fell to 13,300. 83% of applications received in Q1 2004 had initial decisions reached and served within two months. [Page 10]
- 7. 9,000 appeals were received and 14,115 were determined, 11% lower and 23% lower than in the previous quarter respectively. 3% of applications received in the period April to December 2003 had a final decision within 6 months [Page 11].
- 8. 350,400 asylum applications were made to European countries (EU + Switzerland and Norway) in 2003, 19% less than in 2002. UK received the largest number in 2002, but France was on top of the list in 2003. [Page 12]
- 9. At the start of the year 2004, the number of people of concern¹ in the world was 17.1 million. Asia had the highest number of asylum seekers and refugees, with 6,187,800. The estimated number of asylum seekers, refugees and others of concern as at 1st January 2004 has decreased by 17.4% compared to the same month in the previous year. [Page 13 and 14]

Supported Asylum Seekers in the Region – including dependants

 In the North East there are 10 different Local Authorities supporting asylum seekers. The Chart below shows individual asylum seekers supported in NASS accommodation by the various Local Authorities.



Subsistence Only (SO) supported Asylum seekers

There are **180** asylum seekers in the **North East** who are not in NASS accommodation and receive only subsistence (cash) support from NASS. In total there are 25,465 clients getting only subsistence support throughout the country. The North East had less than 1% of this number. 18,295 (72%) of all asylum seekers in receipt of subsistence only support were located in London.



As at end June 2004:

- The top **10** nationalities in the North East region are shown below:





Supported Asylum Seekers by Region - including dependants

The totals below represent the numbers of asylum seekers who are currently in NASS accommodation or are in receipt of subsistence (cash) only support. They reflect the numbers of new applicants granted support and exclude applications for those for whom support has ceased. These figures do not include asylum seekers who are not supported by NASS.

- As at the end of June 2004:
 - 25,465 asylum seekers were receiving subsistence only support
 - 45,135 asylum seekers were supported in NASS accommodation
 - Thus a total **70,600** asylum seekers were in receipt of NASS support as at the end of Q2 of 2004 which is **7%** lower than the previous quarter (Mar-04 = 76,245)

The chart below shows the number of asylum seekers supported by NASS Subsistence only, and by accommodation and subsistence, in different regions of the UK as at the end of June 2004.



- The regions with the highest populations of asylum seekers supported by NASS in order of numbers were: Greater London (30%), Yorkshire and the Humber (14%), West Midlands (13%), North West (11%), Scotland (8%), the **North East is** in sixth place with **7%** of all the asylum seekers supported by NASS in the UK.



• Applications: 7,920, 11% lower than previous quarter


Applications for asylum (excluding dependants) in the UK in Q2 of 2004 totalled 7,920, 11% less than Q1 (8,940).

Nationalities

The largest nationality applying for asylum in Q2 of 2004 was Iran with 685. Below shows the top 10 nationalities applying for asylum in the UK in Q2:




NASS applications - National

• Total applications: 7,695 which was 4% higher than previous quarter

The number of applications for NASS support in Q2 was 7,695 which was 4% higher than Q1 (7,425). Separately, 470 asylum cases were notified that they were not eligible to apply for NASS support on the grounds that their claims were not made as soon as reasonably practicable compared with 890 in Q1.

In Q2 6,085 (79%) applications were from single adults and 1,610 (21%) were from family groups.



• Support type:

- o In Q2, **3,795** (49%) applications were for accommodation and subsistence support and **2,230** (29%) of applications were for subsistence only support.
- o The remaining 22% of applications were classified as invalid.




Asylum application initial decisions - National

- Initial Decisions: 11,720, 20% lower than previous quarter
- 11,720 initial decisions were made in Q2, 20% lower than in Q1 (14,640) but remaining higher than the level of applications.
- Hence the number of cases awaiting an initial decision at the end of June continued to fall to 13,300 (31,400 at the end of June 2003). Of this total, 4,900 cases were in progress, i.e. the application had been outstanding for 6 months or less.
- 3% of initial decisions were granted asylum in Q2, compared with 4% in Q1. The proportion granted Humanitarian Protection (HP) or Discretionary Leave (DL) fell slightly this quarter to 8%. 89% of initial decisions were refusals, a slight increase on Q1.

The Chart below shows the number of Initial decisions made for the period from Q2 of 2002 to Q2 of 2004:




• Timeliness of Initial Decisions

 83% of applications received in Q1 (January to March) 2004 had initial decisions reached and served within two months, compared with 82% for Q4 (October to December) 2003.

Asylum appeals - National

- Appeals received: 9,000, 11% lower than previous quarter
- It is estimated that 9,000 appeals were received by the Home Office in Q2 of 2004, compared with 10,100 in Q1 2004.
- Appeals determined: 14,115, 23% lower than previous quarter
- The number of appeals determined by adjudicators fell in Q2 by 23% to **14,115** from 18,225 in Q1 and was **27% lower** than in Q2 2003 (19,345).
- The proportion of appeals dismissed rose to 78% in Q2 from 76% in Q1, whilst the proportion of appeals allowed fell to 20%, from 22% in Q1.

The Chart below shows the number of appeals determined by Immigration Appellate Authority (IAA) Adjudicators



- As at 30 June 2004, there were an estimated 9,000 appeals lodged with the Home Office which had not been sent to the IAA (a proportion of appeals lodged do not result in appeal bundles being sent to the IAA).
- The total number of asylum appeals in progress in the IAA as at 30 June 2004, was 22,600 (9,900 at the Adjudicator Tier, 7,300 applications for permission to appeal to the Tribunal, and 5,400 Tribunal Appeals).
- Timeliness of case processing, up to and including appeals at Immigration Appellate Authority and Immigration Appeal Tribunal
- 63% of applications received in the period April to December 2003 had a final decision, up to and including appeals at the IAT, within 6 months.

Applications to European Countries 2002 and 2003

In Total 346,600 asylum applications were made to European Countries (i.e. EU plus Switzerland and Norway) in 2003. The highest numbers of applications were made in France (20.4%), UK (17.6%) and Germany (14.5%). The table below shows the number of applications made to European Countries in 2002 and 2003[†]

Asylum seekers and refugees worldwide

- At the start of the year 2004, the number of people of concern¹ in the world was 17.1 million. They included 9.7 million refugees (57%), 985,500 asylum seekers (6%), 1.1 million returned refugees (6%), 4.4 million internally displaced persons (26%) and 912,200 others of concern (5%).
- The global refugee population dropped from 10.6 million to 9.7 million, principally because of the return of nearly 650,000 Afghans from neighbouring Pakistan and Iran.
- There were nearly 290,000 new refugees registered in 2003. Major exoduses occurred from Sudan (112,200), Liberia (86,800), the Democratic Republic of the Congo (30,000), Côte d'Ivoire (22,200), Somalia (14,800) and Central African Republic (13,000).
- During 2003, 809,000 people applied for asylum worldwide. Combined with applications still pending from previous years, the overall total awaiting decision was 985,500 at the end of 2003. Iraqi nationals, who were the largest single group of claimants in 2002, fell to sixth position while the number of Afghans seeking asylum continued to drop, to eighth place.
- The top five refugee hosting countries are: Pakistan (estimate: 1.1 million), Iran (estimate: 985,000), Germany (960,000), Tanzania (650,000) and the United States (estimate: 452,500). All five saw declines of between 2 and 25 percent in refugee numbers.

- As shown on the table above the number of people 'of concern' stood at just over 17 million as at 1st January 2004, down from more than 20 million the year before the lowest total in at least a decade.
- The numbers for Asia fell by more than 30 percent, down to 6.2 million from more than 9.3 million a year earlier. But many people also headed back to their homes in Angola, Liberia, and Sierra Leone the African nations that recently found peace after long periods of civil war.
